¹Special Requirements to Qualify for Specific Deductible Waivers:

- Employer funds 100% of the **Unify SMARTCare™** Employee amount (\$157 per month) for all eligible employees
- All eligible employees are auto-enrolled in **Unify SMARTCare™** (employee only tier). Any employee may buy up to another plan or opt out
- Employer, as the Plan Sponsor and Plan Administrator agrees to adoption of certain limitations and exclusions, pre-authorization requirements, and maximum allowable charges of 140% of Medicare rates (or as negotiated by TPA, but not to exceed Established, Preferred, and Equitable), in their self-insured Plan Documents
- **Unify Healthcare™** is the Program Manager and **Unify SMARTCare™** is the Plan TPA
- Group Medical Questionnaires may be required
- Enrollment Date Requirements: 1. Enrollment needs to be complete by the third Friday of the month; 2. Late Enrollment requires Medical Questionnaires by the 25th from any employees wishing to participate; 3. Enrollment not complete by the 25th will need to be delayed until the following month. **Enrollment in Unify SMARTCare™ Platform can occur at any time complimentary until enrollment complete.**
